授業題目	Introduction to International Law
授業の目的と概要	This course aims to allow students to acquire and extend their knowledge of international law through discussions on fundamental issues in various fields of international law. It will cover topics such as the sources of international law, the relationship between international and national law, the law of treaties, jurisdiction and immunities, state responsibility, the law of international organizations, the use of force, and international dispute settlement.
学習の到達目標	The goal of this course is for students to acquire a deeper understanding of some of the most important issues in international law. A further goal is for students to improve their ability to engage in discussions in English.
授業内容・方法と進捗予定	<p>The course will be conducted in person.</p> <p>The course will be based on discussions concerning fundamental issues in international law. Each week, a chapter of the textbook will be designated together with a set of questions related to some of the most important issues discussed in the chapter. In each class, participants will be asked to answer and discuss the questions to confirm their understanding of the relevant rules and principles of international law.</p> <p>The course is planned to proceed as follows:</p> <ol style="list-style-type: none"> <li>1.
